### Data Privacy Statement

The information provided on this form will be used by Scoil Chualann to apply the selection criteria for enrolment in Junior Infants, and to allocate school places in accordance with the School's Admission Policy and the School's Annual Admission Notice.

Where a pupil is admitted to the school, the information will be retained on the pupil's file.

On acceptance of an offer of admission, this information will be entered in the School Administration System Databiz and will be uploaded to the Primary Online Database. The Primary Online Database (POD) is a nationwide individualised database of primary school pupils, hosted by the Department of Education and Skills.

In the event of oversubscription, a waiting list of students whose applications for admission to Scoil Chualann were unsuccessful due to the school being oversubscribed will be compiled, and will remain valid for the school year in which admission is being sought (See Section 13 – or relevant section – School Admission Policy).

Where a child's name is placed on a waiting list, and the child is not admitted to the school, the information provided on this form will be retained for the duration of the school year and will be securely destroyed thereafter.

Section 66(6) of the Education (Admission to Schools) Act 2018 allows for the sharing of certain information between schools in order to facilitate the efficient admission of students. The information which may be provided to a patron or another Board of Management for this purpose may include all or any of the following:

- (i) the date on which an application for admission was received by the school;
- (ii) the date on which an offer of admission was made by the school;

**Ráiteas Príobháideachais Sonraí**

Bainfidh Scoil Chualann úsáid as an eolas a chuirtear ar fáil ar an bhfoirm seo chun na critéir roghnúcháin maidir le rollú sna Naíonáin Bheaga a chur i bhfeidhm, agus chun áiteanna scoile a leithdháileadh de réir Pholasaí Iontrála na Scoile agus Fógra Iontrála Bliantúil na Scoile. Sa chás go ligtear dalta isteach sa scoil, coinneofar an t-eolas ar chomhad an dalta.

Nuair a ghlacfar le tairiscint iontrála, cuirfean an t-eolas seo isteach i Databiz an Chórais Riaracháin Scoile agus uaslódálfar é ar an mBunbhrbunachar Sonraí ar Líne. Is bunachar sonraí indibhidiúil náisiúnta é an Bunachar Sonraí Bunscoile ar Líne (POD) de dhaltaí bunscoile, arna óstáil ag an Roinn Oideachais agus Scileanna.

I gcás ró-shuibscríofa, tiomsófar liosta feithimh de dhaltaí nár éirigh lena n-iarratais ar ligean isteach i Scoil Chualann mar gheall ar ró-éileamh a bheith ar an scoil, agus beidh sé bailí i gcónaí don scoilbhliain ina bhfuil cead isteach á lorg (Féach Cuid 13 – nó an chuid ábhartha – Polasaí Iontrála Scoile).

Sa chás go gcuirtear ainm linbh ar liosta feithimh, agus nach ligtear an leanbh isteach sa scoil, coinneofar an t-eolas a chuirtear ar fáil ar an bhfoirm seo ar feadh na scoilbhliana agus scriosfar go daingean é ina dhiaidh sin.

Ceadaíonn Alt 66(6) den Acht Oideachais (Ligean Isteach i Scoileanna), 2018 faisnéis áirithe a roinnt idir scoileanna chun ligean isteach éifeachtach mac léinn a éascú. D'fhéadfadh gach ceann nó aon cheann de na nithe seo a leanas a bheith san áireamh san fhaisnéis a fhéadfar a sholáthar do phátrún nó do Bhord Bainistíochta eile chun na críche sin:

- (i) an dáta a fuair an scoil iarratas ar ligean isteach;
- (ii) an dáta a rinne an scoil tairiscint iontrála;
- (iii) an dáta ar ghlac iarratasóir le tairiscint iontrála;
- (iv) sonraí pearsanta mic léinn lena n-áirítear a ainm, a sheoladh, a dháta breithe agus a uimhir phearsanta seirbhíse poiblí (de réir bhrí alt 262 den Acht Comhdhlúite Leasa Shóisialaigh 2005).
